

## PRASANT'S MESSAGE




As we step into this new financial year, I am pleased to share key updates from our programmes. We are proud to announce the restarting of leprosy activities in Uttar Pradesh, with a new Referral Centre in Varanasi. This marks a significant milestone in our journey to re-establish a strong presence in one of the highest-burden regions. A thorough review of our LF programmes was conducted, with a focus on integrated care for affected individuals. The discussions reaffirmed our commitment to combining morbidity management with mental health support and community mobilisation. The Swabhiman programme, embedded within our LF response, continues to empower affected persons—particularly women—to become change agents in their own lives and communities.

I am also pleased to share that Mankind Pharma has renewed its support for the next three years, strengthening our capacity to scale services in leprosy and LF. Their continued commitment is a powerful endorsement of our work and values. Additionally, I had the privilege of attending the Management Committee meeting of the GoodBye Leprosy Trust, where we explored collaborative strategies to accelerate the elimination of leprosy through innovation, partnerships, and advocacy. These discussions are vital as we work to amplify our collective voice at national and global platforms. Together, with the unwavering dedication of our teams and the support of our partners, I believe we are moving closer to a future where leprosy and LF are no longer causes of stigma, disability, or exclusion.

## IMPACT STORY

Rukumani Sahoo, a 69-year-old woman from Kudahansa village in Mayurbhanj district, Odisha, lives with her husband amidst financial hardship. Illiterate and part of a Below Poverty Line (BPL) household, she endured years of suffering due to leprosy, which led to the loss of fingers on both her hands and feet. These physical deformities severely limited her mobility and ability to perform daily tasks, leaving her emotionally isolated and stigmatized—even within her joint family. Her husband, a daily wage labourer, struggled to support them. During a line listing activity, LEPRO Society identified Rukumani and offered compassionate counselling, regular follow-ups, an Ulcer Care Kit, and protective footwear—bringing much-needed relief and improving her comfort and dignity. Through livelihood support, Rukumani and her husband were able to open a small shop near their home. This has become a stable source of income and restored their sense of independence. Today, Rukumani feels financially secure and emotionally empowered. She expresses deep gratitude to LEPRO Society for transforming her life and now stands as a symbol of strength and resilience in her village, inspiring others to seek support and rebuild their lives.

- Compression garments helping to reduce swelling, supplied to LF infected persons.



- National Level Training of Trainers on Revised Lymphatic Filariasis (LF) Elimination Guidelines organized by National Vector Borne Disease Control Programme (NCVBDC).
- Vidhan Sabha Speaker Mr. Devesh Chandra Thakur gave and facilitated pension benefits and



education support for individuals affected by leprosy.

- ASPIRE Pilot Project was presented at WHO's Second Global Meeting on Skin NTDs in Geneva as a model for integrated screening and treatment.
- ASPIRE project mid-term evaluation activities were carried out with stakeholder meetings and field observations led by Mr. Guillermo.



- Outpatient services included clinical consultations and nerve function assessments.
- Follow-up activities for Under Treatment cases, contact surveys, and monitoring of reaction cases were conducted across several blocks.



- A Disability Care Camp was conducted at WDRC in Delhi, where participants were trained in self-care practices to prevent disability and recurrent ulcers.



- Customized MCR footwear and Walker bar were distributed to enhance mobility and well-being of individuals affected by leprosy.



- District NLEP Chandrapur provided MCR footwear to leprosy-affected individuals across the district.
- Metacarpophalangeal (MCP) extension block was applied on the day of suture removal after claw hand correction through Reconstructive Surgery (RCS), to support proper finger alignment and healing.

## Meet Our Staff

**How did you join LEPRA, and what work do you do?**-I joined LEPRA Society in July 2022 and currently serve as Field Coordinator at Jagdalpur RC, Bastar District (Chhattisgarh). I work across three blocks and the Comprehensive Care Centre, focusing on leprosy and lymphatic filariasis.

**How do you engage with communities to raise awareness, reduce stigma, and promote early detection?**- Many people approach us at advanced stages, often with disabilities. To promote early detection, we train traditional healers and grassroots health service (GHS) providers in tribal areas like Bastar, leveraging their trust within the community.

**What strategies help manage and motivate a diverse team in leprosy initiatives?**- Developing locally tailored IEC/BCC plans and involving key influencers such as PRI members, GKS, ASHAs, traditional priests, and government health staff can effectively mobilize the community and ensure program success.

**What are the key challenges in leprosy control, and how do you address them?**-High prevalence and delayed detection, especially among women, are major challenges. Surveillance and follow-up are often lacking. We address this through regular monitoring, POD/POWD activities, and identifying NFI cases to prevent disability. While stigma is decreasing, more efforts are needed in community education.

**Share a beneficiary story that is close to your heart.**- A woman from Nangoor village faced severe ENL reactions and stigma from her family. With counseling and treatment at our LEPRA Care Centre, her health improved, and she is now happily married, living a normal life.
