Impact story

Santi Das, a 60-year-old woman from Kateswar, Malatipatapur in Purisadr Block, Puri District, has been grappling with Grade 2 Lymphatic Filariasis (LF) affecting her left leg for the past 20 years. Her condition initially manifested with fever and left-side inguinal adenitis, progressing to severe swelling despite various treatments. Suffering from acute attacks and frequent entry lesions on her leg's middle finger, Santi faced significant challenges, including stigma and lack of hygiene awareness.

LEPRA Society intervened decisively, addressing these challenges comprehensively. Santi, accompanied by an ASHA worker, visited the MMDP center in Chandanpur in December 2022, where she received DEC treatment and training in self-care practices. Dr. Acharya supervised her treatment for entry lesions, and LEPRA facilitated her access to government medical facilities.

Since LEPRA's intervention, Santi's health has significantly improved. Her leg swelling has reduced, acute attacks have ceased, and she now feels happier and more confident. Beyond health benefits, LEPRA's support enabled Santi to engage in terracotta work with other village women, where she has gained skills and earns income by selling her creations.

Santi's life has undergone a positive transformation, thanks to LEPRA's holistic approach, fostering not only physical recovery but also emotional well-being and economic independence through vocational empowerment.

State Wise Updates

ANDHRA PRADESH



- Received a Fostercare cheque from KCP Limited through the Vice President and CSR Head.
- Footwear distributed by Rotary Club of Vijayawada members in Vijayawada RC.
- TLM Vocational College Principal visited Eluru RC and Vizianagaram RC, interacting with RC staff, shoe technicians, and PHC medical officers.
- DPMR camp conducted in AMG Colony, Narva with DLATO and NLEP staff; footwear distributed by DLO.
- Mankind CSR Head visited Vijayawada RC, Sreyassu, and Tenali, interacting with beneficiaries and issuing IGP cheques.
- IGP support cheques distributed by Dist. Malaria Officer, Machalipatnam to 4 LF patients.

BIHAR



- NTDs workshop organized by IGIMS and WHO in Bihar discussed prevention, diagnosis, and treatment strategies, with IGIMS PG students, faculty, and state representatives; SPO (Filaria) praised the efforts in eliminating filariasis in Bihar.
- Constant efforts empowered 90 Self Support Groups in Samastipur, Bihar, on disability management and social schemes by Jaguti team.
- A preparatory meeting for the Mass Drug Administration campaign in 14 districts of Bihar was organized by PCI, with LEPRO team attending as guest orators.
- LEPRO provided 196 pairs of footwear to leprosy-affected individuals in 4 Bihar colonies with support from Samutthan leaders and inmates.

- 16 new cases detected at Jagdalpur RC.
- 58 OPD cases attended, 35 nerve function assessments done, 7 new NFIs identified, 5 improved NFIs, and 7 ulcer cases treated; 4 cases linked with social security schemes.
- NLEP coordination meeting held at Maharani Hospital, Jagdalpur, involving teams from Koraput (Odisha) and Jagdalpur (Chhattisgarh) discussing defaulter retrievals.

CHHATTISGARH



DELHI



- WDRC team in Sagarpur, West Delhi listed LF cases and demonstrated home care practices, reducing swelling and acute attacks.
- Indira Gandhi Hospital's camp at Ekta Vihar Kusth Samiti provided footwear and self-care kits to leprosy-affected individuals.
- Fifty individuals were examined and educated about leprosy at Tahirpur; no new cases found.

JHARKHAND



- Nirmala Leprosy Hospital in Govindpur, Dhanbad, and RC Sparsh Dhanbad provided 25 customized footwear to leprosy-affected individuals.
- Dr. Shekhar Sheshadri from NIMHANS visited RC Sparsh and appreciated the comprehensive disability care services for NTDs in partnership with TATA-LEPRO.

ODISHA



- Participated in block-level coordination meetings, NLEP review, and conducted ASHA worker training across Bahalada, Rairangpur, Pandupani, and other locations in Mayurbhanj.
- Organized Self-Care Camps, formed Self-Support Groups, and conducted demonstrations and talks on leprosy and LF at multiple sites including Tiring CHC and Jagannathpur Village. Held 2 self-care camps for 52 leprosy beneficiaries and formed a leprosy forum in Jharbandh with 14 members.
- Detected cases through active case detection and provided self-care camps at Junagarh and Kasagumunda, benefiting leprosy-affected individuals.
- Established a Leprosy forum in Kasagumunda Block, conducted a Focus Leprosy Campaign covering 16 villages, and held International Yoga Day at KCC.

- Conducted self-care demonstration camp in Malasahu Purisadar Block, educating people on health conditions and promoting self-care practices.
- Our eye care team in Odisha recently conducted an Eyecare strategy meeting at MNC, Pandapali, BNpur. The meeting focused on enhancing eye care services and developing effective strategies to reach more beneficiaries in the region.

TELANGANA



- Conducted meetings with health officials to sensitize about disability certificates for persons affected by leprosy.
- Hosted IMT - Institute of Management & Technology students for interactive sessions and practical demonstrations on leprosy and its effects.
- Initiated a collaborative weekly clinic at Bhaskar Medical College with dermatology experts and district NLEP team.
- Organized a primary school student screening program in collaboration with local ASHAs and NLEP team in Hyderabad district.
- Conducted MMDP camps, including practical demonstrations on self-care practices and distribution of self-care kits to patients in Nirmal district.

A memory at LEPRAs which you would like to share?

I get a lot of support from my team and seniors and the informative sessions of the annual meeting organized by Lepra are memorable.

How do you plan to engage with local communities to raise awareness about leprosy, reduce stigma, and encourage early detection and treatment?

We organize awareness programs in collaboration with local NMA, Asha workers and health care workers of NHM and support the patient or his family in whatever way we can.

In your opinion, what are the most significant challenges in leprosy control, and how would you address them in your role as a Physiotherapist?

The most important challenge for me as a physio is to overcome the pathology of the patient or some patients may not be able to follow up regularly or the patient may be a migrant to another state.

Share a beneficiary story that is close to your heart?

I found an elderly leprosy patient in the campus area of Maharaja Yashwant Rao hospital's referral center in Indore. Who had 2nd grad deformity (claw hand) and wounds in bilateral foot, he had no one in his family and no house to live in. We together with the team and the department head of the hospital arranged for us a shelter home in which we will have free accommodation, food and necessary medical facilities.
